Cynthia L. Morgan is the chief financial officer and served as the budget officer for the Defense Commissary Agency, headquartered at Fort Gregg-Adams, Va. Ms. Morgan is responsible for all financial aspects of the agency's retail sales and operating budgets. This includes budget oversight that exceeds \$4 billion in DeCA resale funds, \$1.2 billion in operating funds and \$300 million in commissary surcharge funds, annually.

DeCA has more than 13,000 employees serving in a headquarters and five area offices supporting nearly 240 commissaries located in 13 countries worldwide.

She also serves as the agency liaison with the Office, Secretary of Defense, Comptroller's Office and the Defense Finance and Accounting Services.

Ms. Morgan previously served as budget officer where she managed the agency's budget requirements, analysis, execution and policy and financial accounting activity. Before that assignment she worked as director of accounting, where she managed the reporting of the agency's financial statements, financial audit and financial operations. She has over 30 years of experience within the financial management community with DeCA, DFAS and DLA.
